





#### From Kuala Lumpur International Airport (KLIA)

Approximately 1-2 hours journey from the KLIA, via airport transfer bus, ERL train or taxi.

#### From Kuala Lumpur Sentral Station

Approximately 30 mins journey from KL Sentral Station via Rapid Rail, taxi and Rapid Bus. Interchange from all train line into the LRT Kelana Jaya line.

Recommendation to use GPS apps to plan your journey via driving. Campus is located in the heart of Kuala Lumpur City Centre. Traffic flow is expected to be busy.

The nearest Rapid Rail is Ampang Park Station using LRT Kelana Jaya line. The nearest interchange station is at Masjid Jamek Station . A brief 5 minutes walk to the main campus from the station.

# **Students Attire**

#### The Minimum Requirements For Male Students' Attire

#### Hair

The length of hair should not extend beyond the neckline and ears; also the hairstyle should not be of unusual or extraordinary fashion.

#### Shirt

Shirts and T-shirts with collars are allowed to be worn when attending classes. Except for bush jackets, buttoned Malay dresses, batik shirts and other proper national dresses, the shirts and T-shirts should be tucked in. T-shirts without collars are not allowed to be worn during formal university functions and other formal activities unless explicitly allowed by the authority for certain specific functions.

#### Pants

Jeans are not allowed to be worn except for non-formal occasions and during physical activities such as sports or recreation, provided that they are not tight-fitting, multi-coloured, faded, fancy in design, torn or with patches.

Shorts are not allowed for all students.

#### Shoes

Slippers and non-strip sandals should not be worn during office hours, lectures, tutorials and other official functions at any Unit of the university.

#### Nail

Nails should be clean and well-cut. Unusual and extraordinary colours of nails are not allowed.

#### Accessories

Neck and wrist chains should not be worn except for medical purposes or on religious grounds. Body piercing on any part of the body is not allowed for male students. Body tattoo is prohibited for all students.

#### The Minimum Requirements For Female Students' Attire

#### Hair

Hair should be properly combed. Students are not allowed to dye their hair except with `inai".

#### Make-Up And Accessories

Female students are not allowed to wear heavy make-up. Excessive accessories and strong perfume are not allowed. Body piercing is not allowed except for ears or on religious grounds

#### Dress

The attire should not be tight-fitting. The attire should be made from materials such that the colour of the skin and the shape of the body would not be visible. The design of the attire should not reveal any part of the body which has to be covered according to the norms. Dress materials should not be transparent or reveal the contour of the body. Sleeveless t-shirts are not allowed for female students.

#### Skirts

Sarongs and skirts may be worn if they are loose and must be below the kneecaps.

#### Pants

Tight-fitting trousers or pants and shorts should not be worn during classes or during formal university functions and activities and around the Study Centr

#### Shoes

The heels of the footwear should not be excessively high.

#### Nails

Nails should be clean and well-cut. Unusual and extraordinary colours are not allowed.



# **PTPTN Education Loan**

PTPTN Education Loan (National Higher Education Fund Board / Perbadanan Tabung Pendidikan Tinggi Nasional)

Financing studies is a very important aspect of every student's education plan. Some students need financial assistance to complete their courses at the university. As such, Universiti Tun Abdul Razak (UNIRAZAK) has set up a special unit to assist students in their application for financial assistance, especially from the National Higher Education Fund Organisation (PTPTN) and other organizations or foundations, which provide scholarships and study-loans.

Though UNIRAZAK is a private institution and profit-oriented entity, it also offers scholarships from a special fund. Other financial aids are provided for cases of emergency or death. UNIRAZAK also gives out special short-term loans or grants on a case-to-case basis and on humanitarian grounds with considerations based purely on merit.

PTPTN is a special fund established under the auspices of the Ministry of Education with the objective of offering educational loans to all eligible Malaysian students pursuing their tertiary studies at selected institutions of higher learning in the country.

UNIRAZAK has been included in the list and the facility is meant for both the Bumiputera and non-Bumiputera students studying at UNIRAZAK.

Hence, all undergraduate students of UNIRAZAK are eligible to apply for the facility and to date, more than ninety-five per cent of the applicants have been successful in their applications.

#### Airport pick-up & arrival arrangement

The university will provide airport pick-ups when the pre-registration fees payable by international students are completed. As per the requirement of the Immigration Department of Malaysia, a University representative must meet the student upon arrival at the airport. Staff from the ISU (International Student Unit) will meet the student at the Immigration checkpoint based on the arrival details provided by the student.

International students are required to inform the details of the arrival time and flight information to ISU approximately 10 days prior to the student's arrival. The registration in UNIRAZAK will be completed upon the student's arrival at the UNIRAZAK campus, to be advised by the ISU officer.

#### Security bond fee

This fee is required to be paid to the Immigration Department of Malaysia and is refundable when students complete their studies and depart for their home country.
