This unique 4-year accounting degree programme, developed in partnership with Certified Practising Accountants (CPA) Australia, provides a short route to achieve professional accounting qualification. It is designed in such a way that the students after completing 3 years in the programme, they need to take the Final Level 5 papers of the CPA and upon clearing these papers, they are awarded UNIRAZAK Bachelor of Accounting (Hons) degree and professional qualification from CPA Australia. With 3 years of relevant work experience, they can obtain full membership of CPA Australia and Malaysia Institute of Accounting (MIA). In addition, they may also obtain a membership of CIMA by passing the Strategic Case Study paper. This programme also has collaborations with a world class university. Under UNIRAZAK-Waikato twinning programme, students after 2 years 1 semester in UNIRAZAK can pursue their studies in New Zealand for an additional one year to be awarded Bachelor of Business (BBus) majoring in Accounting degree by University of Waikato. Upon completion of their third year in University of Waikato, they will return to UNIRAZAK to sit for the 5 papers of CPA Australia in their final (fourth) year.

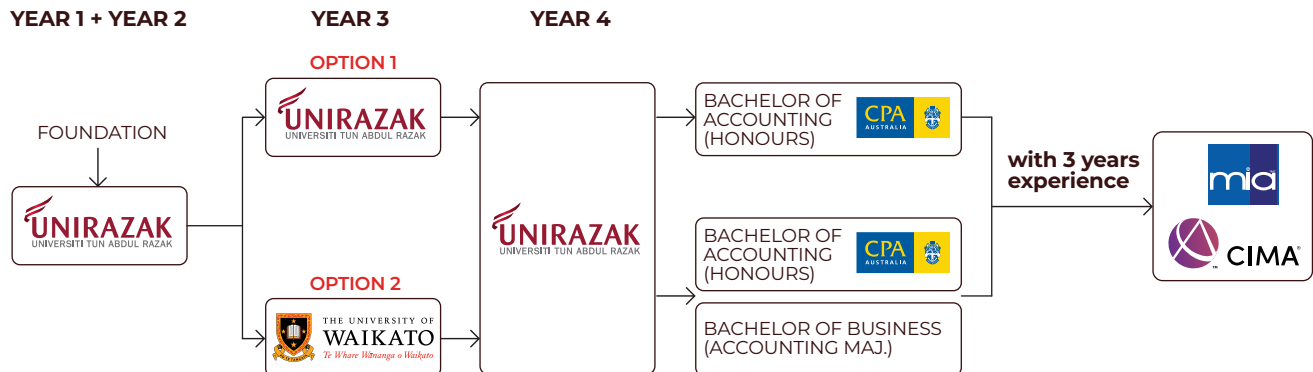

Malaysian University English Test (MUET) Band 2 AND

- i. A pass in STPM or its equivalent, with a minimum Grade C+(GP 2.33) in any two subjects, and credits in Mathematics and a pass in English at SPM level; OR
- ii. A pass in Sijil Tinggi Agama Malaysia (STAM) with a minimum grade of Jayyid, and credits in Mathematics and a pass in English at SPM level; OR
- iii. A diploma in accounting or related field, or its equivalent with a minimum CGPA of 2.50, and credits in Mathematics and a pass in English at SPM level; OR
- iv. Matriculation/Foundation qualification or its equivalent with a minimum CGPA of 2.50, and credits in Mathematics and a Pass in English at SPM level.
